"Unprecedented." While an accurate description of the year that FY'20 turned out to be, it fails to convey the full picture of how many areas of our operations have been substantially impacted by a variety of issues throughout this past year. Beginning with financial impacts of service denials and limitations by managed care organizations, ending with a global pandemic that shut down the world, our challenges this fiscal year were ominous and relentless. While we experienced the first-ever large-scale furloughs within the organization due to complications with the managed care organizations, we also closed facilities, transitioned to remote work, implemented additional temporary furloughs, and had a large portion of the organization on rolling furloughs for an extended period under the impact of the COVID-19 pandemic.

Our struggles have been no different than those of other organizations. However, as an organization, I am proud to say that we chose to turn lemons into lemonade at every corner. By increasing our focus and efforts toward clear and transparent communication across all levels of the organization, our staff were able to remain aware of ongoing changes and decisions, as well as understand how HCS intended to manage the impact of the pandemic. This knowledge and understanding allowed staff to have

trust in HCS leadership and transition through some very unorthodox interventions and an endless stream of unusual situations to end the year on a successful and safety-focused note. Miraculously, our staff were able to shift the entire organization and our consumers from face-to-face, facilitybased services to fully remote telehealth services within one week. They were flexible enough to navigate through rolling furloughs and dedicated enough to ensure there were no service gaps for our consumers and community.

Despite the inescapable challenges we have been forced to experience this year, I am exceptionally grateful and proud of the successes and outcomes this organization has achieved in such a tough environment. In the face of so many uncertainties, we have learned that we can operate much differently than we ever envisioned while continuing provision of quality and meaningful care to those we serve. With no clear end in sight, this practice-changing experience has not only prepared us to better navigate continued obstacles, but also to begin to develop a different vision and definition of what our "new normal" can be. Prioritizing health and safety for employees and consumers, we look forward to the creative opportunities that are to come.

# \$22,830,217

Revenue decreased by \$1,150,938 or slightly over 4%. Dropping total revenues to just over \$26.5 million. Fees remained the highest revenue category at **60**% with State funds the second highest at **21**%. Personnel expenditures remained the highest expenditure category at **72**%. The total surplus was \$**832,352** which consisted solely of restricted funds. HCS ended the year with a **8.87**% decrease in Net Position, but remained financially stable due to the dedication and creative thinking of HCS staff, management and board members which helped mitigate some of the effects of COVID-19 revenue interruptions and related drain on HCS financial resources.


